Privacy Policy

(I) The person responsible for processing the personal data contained in this "Registration Form" is the Civil Aviation Pilots Union ("SPAC"), headquartered at Rua Frei Tomé de Jesus, 8 1749-057 Lisboa PORTUGAL, telephone +351 217 926 800 and e-mail address geral@spac.pt; (ii) The contact details of the data protection SPAC, namely for member registration, collection of contributions, contacts with the member and creation of an account on the SPAC website and mobile application; (iv) The transmission of personal data to third parties depends on the consent of the member; (v) The member has the right, at any time, to request SPAC, through an email to rgpd@spac.pt, access to personal data concerning him, its rectification or deletion and the limitation of processing, as well as to oppose the processing, request data portability and submit a complaint to a supervisory authority; (vi) Personal data is kept for a period of 5 years after the termination of membership, unless there are overdue contributions, in which case until full settlement of the debt is maintained, with the exception of the name and identification number, which are kept until retirement age; (vi) The processing of personal data is a necessary requirement for registration with the SPAC; (vii) Pursuant to Article 6/1/a) of the GDPR, with the express consent of the member, the respective email address may be used for the purpose of SPAC marketing communications, such as newsletters, news, technical articles, information about events or other related activities, for a period of 2 years from this date.
